REPORT

Council has for many years used Panel Contracts and Expression of Interest (EOI) Panels for supply of various goods and services.

- Bituminous Products.

In recent times the use of some of these Panels have changed, these changes include:

- 1. The use of Local Government Procurement's Contract Bitumen, Emulsions and Asphalt Materials and Services (LGP213) Contract instead of Council's own Contract, and
- 2. The value of expenditure under some of the previous EOI Panels has increased whereby they now should be run in accordance with the Tendering provisions in s55 of the Local Government Act 1993.
