EXECUTIVE SUMMARY

- The purpose of this report is to seek Council's endorsement of the Audit, Risk and Improvement Committee Panel's selection of a new member.
- It is recommended that Council approve the appointment of Mr Christopher Davies to the Audit, Risk and Improvement Committee and thank the outgoing member, Mr Andrew Hanigan for his significant contribution to the Audit, Risk and Improvement Committee during his tenure.

REPORT

Council's external Audit, Risk and Improvement Committee members are appointed for a four (4) year term, with a staggered replacement program of each member.

The rotation of members is in line with best practice principles and supports the oversight of ongoing matters; ensures the continuity of the internal audit function and aids in maintaining the independence of the Audit, Risk and Improvement Committee.

The appointment of external members to the Audit, Risk and Improvement Committee is important in the ongoing culture of policy compliance, business improvement practices and good governance. The Committee provides an assurance role that promotes the need for accountability.

Council called for Expressions of Interest for an independent member to fill a vacancy. Applications were accepted up until 5 February 2018. A total of six (6) strong and competitive submissions were received.

A preliminary assessment of applications was undertaken by a panel comprising of:

- Executive Director Community & Corporate
- Director Infrastructure & Environment
- Chief Financial Officer

A short-list was determined and interviews held. Each of the interviewed applicants were assessed against predetermined criteria with panel members unanimously agreeing on Mr Christopher Davies as the preferred applicant.
