EC4 Adoption of Revised Hardship Policy

EXECUTIVE SUMMARY

- Council's current Hardship Policy was last revised in April 2015.
- A Notice of Motion seeking support for primary producers affected by drought was considered at the March 2018 Council meeting where it was resolved to investigate and implement measures to support them, including a review of the Hardship Policy.
- A review of the Policy has identified a number of amendments that will provide greater clarity of the requirements of the Policy and the Local Government Act.
- It is recommended that the Revised Hardship Policy be adopted.

REPORT

The policy provides transparency when assessing claims for relief due to financial hardship, ensuring a fair and equitable approach is followed.

The policy will comply with the relevant sections of the Local Government Act, the Regulations and other applicable legislation and will allow for a fair and equitable approach to assessing genuine claims of financial hardship.

This policy was last revised and adopted by Council in April 2015. Best practice suggests that this Policy should be reviewed at least every three years and therefore a review was recently undertaken.

A Notice of Motion seeking support for primary producers affected by drought was considered at the March 2018 Council meeting where it was resolved to investigate and implement measures to support them, including a review of the Hardship Policy.

The provisions of the Hardship Policy are largely dictated by the requirements of the Local Government Act 1993 and it is difficult to single out one category in favour of another due to the requirement to maintain equity. Notwithstanding, the Policy wording has been amended explicitly limiting eligibility for hardship relief to residential and farmland rating categories only (refer section 4.1.4). This limitation was previously only implied.

The review has also highlighted opportunities to reword a number of sections of the Policy to provide greater clarity of the requirements of both the Policy and the Local Government Act 1993. Each of the changes are detailed in the attached summary sheet.
