# GO3 Proposed Locality Boundary Change - Brownlow Hill 239945

#### **EXECUTIVE SUMMARY**

- That Council agree to the locality boundary change of the three (3) land parcels within the Brownlow Hill Estate, (Lot 101 DP 1174065, Lot 102 DP 1174065 and Lot 1 DP 614348 refer to map), currently in the locality of Orangeville to be within the locality of Brownlow Hill.
- It is recommended that Council support the boundary change for submission to the Geographical Names Board NSW (GNB) for approval and finalisation.

### **REPORT**

Council at its meeting of 18 April 2017 (GO3 62/17) resolved to support the Brownlow Hill boundary change in principle based on the proposal being placed on public exhibition for 28 days to invite community feedback. It was also agreed an additional report would come to Council after the exhibition period for final determination by Council prior to the proposal being submitted to the Geographical Names Board NSW (GNB) for approval and finalisation.

## **PUBLIC EXHIBITION SUBMISSIONS**

The Public Exhibition was held between Thursday 1 June to Thursday 29 June 2017. Letters were sent to all residents in Brownlow Hill notifying them of the proposal and as a result there were no written objections received relating to the proposed boundary change.

Council did receive three (3) phone enquiries relating to the proposal during the exhibition period. All three (3) calls were of a general nature such as, history of the Estate, how to find the location on the website, a development application enquiry and a resident wanting a boundary change to be part of another local government area.

### **BACKGROUND**


The report to Council on 18 April 2017 for the boundary change was based on the evidence that the three (3) land parcels within the estate, Lot 101 DP 1174065, Lot 102 DP 1174065 and Lot 1 DP 614348 are recognised on the NSW Office of Environment & Heritage (OEH) as of State Significance and that the history of the Brownlow Estate originally inspired the Locality name of Brownlow Hill. It is therefore appropriate to contain the Brownlow Hill Estate within the Brownlow Hill boundaries. The proposal was placed on public exhibition for 28 days to invite community feedback with an additional report to Council after the exhibition period prior to the proposal being submitted to the Geographical Names Board NSW (GNB) for approval and finalisation.
